\* SINCE 5 MONTH WE HAVE RECIVED ONLY 1 MONTH OF WAGES, WE ARE SURROUNDED BY A FACING MULTITUDE OF PROBLEM

\* WE ARE UNABLE TO LOOK AFTER OUR FAMILY BASIC NEEDS

- FOOD
- MEDICAL / TREATMENT
- EDUCATION / SCHOOL FEES
- SUPPLY ESSENTIAL FOR LIVING / WATER / ELECTRICITY
- HOUSE RENT / SHELTER TO ACCOMODATE

\* WE ARE UNABLE TO PAY OUR DEDT'S / BANK EMI / BILL'S. CREDITORS THREATNING & MISBEHAVING WITH OUR FAMILY (WOMEN, CHILD, OLD AGE PARENT'S) THEY ARE IN FEAR & STRESS, TENSION

\* WE CREW ONBOARD ALSO DONT HAVE ANY CASH TO BUY RECHARGE CARD'S FOR CALLING HOME REGULARLY. WE MANAGING BY ASKING KIND FAVOR FROM YARD WATCHKEEPER. BEFORE THEY RECHARGE OUR PHONE TOO, IN CREDIT BUT KNOW THEY ALSO NOT DOING. WE ARE MANAGING BY USING HOT SPOT OF YARD WATCHKEEPER. WE ASSURE YARD PERSONEL WE WILL CLEAR THEIR DUE OF RECHARGE ON RECEIVING TRAVELLING ALLOWANCE - 200 USD.

\* DEPRESSION, TENSION, & EXTREME MENTAL STRESS WE ARE FACING WHEN WE CALL HOME WE COME TO KNOW THAT THEY ARE FACING ALOT DUE TO US, WE TRUSTED THIS OWNER & JOINED HIS VESSEL

\* WE ARE UNABLE TO EVEN MANAGE BASIC NEEDS OF OUR FAMILY FOOD, SHELTER - HOUSE RENT / MEDICAL / EDUCATION, LANDLORD & CREDITOR'S ARE THREATNING & MISBEHAVING. WE ARE UNABLE TO PAY OUR CHILDREN'S SCHOOL FEES THEIR FUTURE IS GETTING RUINED TOO, OUR OLD AGED PARENT'S NEED MEDICAL TREATMENT WE DONT HAVE ANY MONEY FOR MANAGING.

→ WE REQUESTING YOU ALL ARRANGE OUR SIGN OFF IMMEDIATELY WE CANNOT AFFORD A SINGLE DAY OF DELAY, SO MANY LIVES ARE SUFFERING DUE TO SUCH PROBLEM. WE CAN MANAGE BY TAKING NEXT JOB ASSIGNMENT SO PLS SIGN OFF US AT URGENT

→ ITS BEEN MORE THAN 1 MONTH AS CREW AGREED AS PER OWNER TERM'S HE IS UNABLE TO RELIVE US WE ARE STILL ONBOARD & LOOKING FOR HIS VESSEL & MANNED IT. SO HE NEED TO PAY ONE MORE WAGES TO CREW IMMEDIATELY TO SAVE



- THE LIFE OF CREW & CREW FAMILY

→ WE KEPT BACK IN SHIP DUE TO SAFE MANNING. AS OWNER TO UNABLE TO SEND US DUE TO THAT DUE TO CREW ONLY HIS VESSEL COMPLY WITH INTERNATIONAL REGULATION'S, HE NEED TO PAY US FOR THAT. WE ARE ENTITLED TO GET FULL WAGES UPTO SIGN OFF.

→ WE ALWAYS CO-OPERATING, COME UP WITH POSITIVE OUTCOME PLEASE AT EARLIEST, BECAUSE WE HAVE TO LOOK AFTER OUR SAFETY TOO, PLS ARRANGE SIGN OFF IMMEDIATELY

DONT FORCE US TO LEAVE THE VESSEL. BECAUSE ~~THE~~ OWNER WILL BE RESPONSIBLE FOR ALL THE SITUATION & PLAN ARISE YET. CREW IS JUST LOOKING FOR THE SAFETY. SO SEND US HOME, BEFORE ANY MISHAPPENING. OUR MENTAL LEVEL NOT GOOD WE ARE UNDER DEPRESSION TENSION & LOTS OF STRESS.
